### **DECEMBER MINUTES 2008**

Monday December 15th, 7:30 - 8:30 pm, CENTRAL/WEST, 55 Sherbrooke Ave., Hintonburg - thanks to Kathleen for hosting this meeting!

## 1) Midwifery Updates:

### a) billing at the Montfort

Due to the recent, unfortunate, surprise billing trickling in for clients that gave birth weeks ago, midwifery practices with privileges at the Montfort are now informing all clients that without insurance coverage for a private room, they have an initial **2 hours** in the new LDRP (Labour Delivery Recovery Postpartum) room. All LDRP rooms are private rooms.

The concept of these rooms is that the birthing mother and her newborn don't move to another room shortly after birth, but remain in one room for the duration of their hospital stay ie: labour-delivery-recovery-postpartum (LDRP).

After 2 hours, clients without private room coverage must request a room transfer (to a semi-private, or ward room) for the remaining hospital stay (which for midwifery clients is typically only another hour or two) to avoid being billed. If another room is unavailable (which is often the case), the client will remain in the private LDRP room without being billed.

Karen, a consumer group member, is a Health Economist, and has volunteered to draft a letter of response to the Montfort, to highlight, from a financial perspective, how impractical and costly their policy is, given that they will have to needlessly clean 2 rooms, etc. Many thanks to Karen!!!

#### b) practice updates:

Donna has heard back from a couple of the practices - no reports, but there may perhaps be news in the new year...

Waiting list numbers (numbers are very high once again), are posted on our website.

Leeds-Grenville is currently the only practice without a waiting list.

c) The Ottawa Hospital (TOH) - privileges, response to Mr. & Mrs. X (Diane P.)

Diane Parkin, Head Midwife at The Ottawa Hospital, shared that there are 3 midwives with active privileges (Diane, Celine, Betty-Anne) and 4 midwives with consulting privileges (Teresa, Miriam, and 2 other midwives) at TOH. These midwives are from several different midwifery practices, thereby making it logistically impossible to continue to do births there, hence the move to the Montfort.

TOH is the only tertiary hospital in Ontario without midwifery births.

It is possible that our midwives may return to TOH at some point in the future, which is why the 7 midwives with active or consulting privileges are choosing to maintain their privileges, even though birthing with a midwife at TOH is not currently an option (due to the TOH's suspected politically motivated position to focus on 'high risk' deliveries only, even though 'high risk' accounts for a small percentage of deliveries).

**Bacn** (pronounced bacon) is the term given to electronic messages which have been subscribed to and are therefore not unsolicited but are often unread by the recipient for a long period of time, if at all. Bacn has been described as "email you want but not right now."[1][2]

Bacn differs from spam in that the emails are not unsolicited: the recipient has somehow signed up to receive it. Bacn is also not necessarily sent in bulk. Bacn derives its name from the idea that it is "better than spam, but not as good as a personal email".[3]

The term Bacn was originally coined in August 2007 at PodCamp Pittsburgh 2, and since then has become popular amongst the blogging community.

Common examples of Bacn messages include news alerts, messages from social networking sites and wiki watch lists.

The word has also attracted attention in the professional email marketing community. Commentators have welcomed the distinction from spam and used the term to focus businesses on the need to improve the quality and value (to the recipient) of these kinds of transactional messages.[4]
