## 1) Midwifery Updates:

Jackie Whitehead, RM, phoned in to our meeting, at 7:30pm, from Ancaster.

She stated the importance of the following items for our letters of support for the Barrhaven/Riverside South Clinic proposal:

# NEW DATE FOR LETTERS OF SUPPORT-Feb 15th, 2009. Mail directly to Jackie.

## -Jackie stated some very IMPORTANT POINTS, that could be helpful, when writing our letters of support:

\*the need for Midwives to serve South Ottawa residents, in ENGLISH, with privileges attached to the Ottawa hospital, so that clients need not worry about language issues at the Montfort, nor the lengthy drive to the Montfort hospital, from south Ottawa, and surrounding areas.

\*the need for lots of letters, and lots of support from practices, future Barrhaven/Riverside South clients/taxpayers, current midwifery clients, previous midwifery clients-en masse letters, will be the best approach. One of the reasons that the TWO other practice proposals were recently turned down by the key decision makers, was due to lack of support from consumers and practices.

\*the importance of location of need both of Ottawa South residents and of need to be in the Ottawa Hospital, for proximity during labour/delivery.

\*the important aspect that the more clinics, the more midwives, the more growth, and that having another practice WILL NOT take away from other practices in the Ottawa area, but that having another practice will only help in the reduction of waiting lists, and will support families having babies in Ottawa.

WE NEED TO SUPPORT JACKIE! WE NEED TO SPREAD THE WORD TO OUR ON-LINE FORUMS, (Facebook, Mothering.com....,) CONTACT LISTS, BUSINESSES IN RIVERSIDE SOUTH AND IN BARRHAVEN, ETC. ETC.

It was a privilege to be able to serve the birthing women and their families by bringing this screening to the community, to show that there are endless birthing possibilities and for women to strive to achieve their dreams as far as their options go. I could not have done this without the dedication and commitment of my colleague and friend, Andrienne Prest - it was truly a team effort. She supported this project unconditionally. Also, Jackie MacNair and Gina Merlin made up the core team of 4 of us.

Written contributors should respect client/patient privacy and speak about the doula's perspective and role within birth. We are not necessarily looking for birth stories but more stories of how you felt, what you saw, funny stories, things that made you shake your head, things that kept you up at night - your reasons for persisting as a doula, what you carry with you and think about with regard to your clients, your joys, difficulties, why you quit, why you only do home birth or hospital birth - we want to hear it all. We want you to rant, to philosophize, to share what your gut tells you, to share your visions of birth. We'd appreciate very real, tangible stories of your own experiences, in your own words and voice and from the perspective of the very unique and valuable role that doulas play at birth.

If you are interested in contributing to this collaboration, it can be a notable publication addition to your CV/resume and broaden your publishing credits. Payment for the articles are honoraria of a copy of the book.
