I just wanted to share a little bit about the LIHNs work I have been doing, and you may want to post this to the whole list in case anyone else would like an update. I am sorry that I missed the meeting yesterday, but with a long workday & long commute on Mondays/Wed/Fri, and very regular,

very long LIHN meetings right now, I am feeling a bit swamped.

The amazing news is that the LIHN committee is absolutely the most important work I have done on maternity care issues yet. This is actually the place where policy will be decided & money will be doled out. At the first meeting of the whole maternity care committee (65 people) I was invited to address the group as the sole consumer. To say that this group has the key decision makers is an understatement - the heads of OB, Neonate and Peds at EVERY hospital in our region, along with directors of maternity for all hospitals, anaesthesia, nursing, transport, newborn, midwifery, family docs, PICU, plus the ministry people are ALL there. My subcommittee (21 people), which is responsible for the "taking care of moms & babies" part of the picture, includes the OB head of every hospital, midwives, head nurses, community care, anaesthesia, peds, family

docs, etc. I am not name dropping here, but instead trying to share with you the amazing news that we are finally at the biggest table there is! AND number 4 of the 6 "deliverables" that our committee has is to consider the creation of a new birth center!!!

The workload is crazy, but it is very, very rewarding to think that the years of committee work I have already done may actually lead to something

real this time ....

I will keep you all posted, but please know that I am working hard to protect not just midwifery, but quality birth care in Ottawa...

ALSO - if any of you have opinions/plans/info about birth centers, now is the time to forward them to me. We are currently working on that & now is the time to share your ideas. Sheila

## update:

Yes, progress is being made on the button idea. I found a company in Toronto that does buttons for a good price... they require a good copy of the logo to provide an accurate quote. I look forward to sharing the info and ideas at the meeting tonight. Here's the info & link so you can get an idea... (if the pics don't show up, it is all just copied and pasted from the website http://www.artik.com/Buttons.html#3).

My suggestion would be to do the rectangle or square shape with the CSMC logo. This would be ideal, to stick with the existing logo and name to get the repitition and exposure rather than to possibly dilute the "brand" with another slogan. I suggest getting in as high a quantity as possible in order to increase the amount of money we can make from this project. I believe we could easily sell these items for \$2 each, perhaps even \$3 or \$4.... If we got 1000 rectangular pins for example, the price would be \$0.67 each or \$670. For the square pins, 1000 would be \$0.50 each or \$500.

Bonus: I called the office and was informed that there is no set up charge for these pins... ie- the price per item is the whole price to be considered. I didn't ask specifically about the round pins, but can verify that it is the same.

Alberta delivers good news for midwives, expectant mothers

After public pressure, the Alberta government announced it will cover the costs for expectant mothers who choose to deliver their babies using a midwife.

Starting April 1, 2009, midwifery will be added to the maternity services covered by the public health system in Alberta, the province said on Thursday. The average cost of using a midwife is about \$3,500.

The province is allocating \$4 million to the Alberta Health Services Board to implement midwifery services in the 2009-2010 fiscal year with the help of the Alberta Association of Midwives.

"This decision will provide better access and more choice for expectant women and will relieve pressure on doctors, nurses and hospitals," said Alberta Health and Wellness Minister Ron Liepert in a news release.

"Expanding the use of midwifery services will also help address the pressures on family physicians and obstetricians."

In May, midwives and their supporters held rallies across the province calling on Alberta to cover their services.

British Columbia, Saskatchewan, Manitoba, Ontario and Quebec already have midwifery legislation. Nova Scotia and New Brunswick are both moving toward regulation.

Expectant mothers can use midwives in hospitals, community birthing centres or their own homes.

But midwives in Alberta are scarce because they must complete a two-year licensing period and run a private practice. According to the Alberta Association of Midwives, there were 29 registered midwives in the province in 2006.
